


CONTRACT AGREEMENT FOR THE PB21-03-011: PROCUREMENT OF SEMI-EXPENDABLES AND OTHER SUPPLIES FOR VARIOUS OFFICES (Reference No. 7515168)

THIS AGREEMENT made this 24th day of March 2021 between **JH CERILLES STATE COLLEGE** of the Philippines (hereinafter called "the Entity") of the one part and **PAUL ALLANIE GENERAL MERCHANDISE** of Palmera, San Pedro, Pagadian City (hereinafter called "the Supplier") of the other part:

WHEREAS, the Entity invited Bids for certain goods and ancillary services, viz., **PB21-03-011: PROCUREMENT OF SEMI-EXPENDABLES AND OTHER SUPPLIES FOR VARIOUS OFFICES (Reference No. 7515168)** and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **ONE MILLION SEVEN HUNDRED SEVENTY-ONE THOUSAND ONE HUNDRED SEVENTY-FIVE PESOS ONLY (PHP1,771,175.00)**, hereinafter called the "**Contract Price**" for items herein attached as Annex A;

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents shall be deemed to form and be read and construed as part of this Agreement, viz.:
 - (a) the Technical Specifications;
 - (b) the Performance Security; and
 - (c) the Entity's Notice of Award.
3. In consideration of the payments to be made by the Entity to the Supplier as hereinafter mentioned, the Supplier hereby covenants with the Entity to provide the goods and services and to remedy defects therein in conformity in all respects with the provisions of the Contract
4. The Entity hereby covenants to pay the Supplier in consideration of the provision of the goods and services and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the contract.
