INVITATION TO BID FOR Procurement of Janitorial/Utility Services

1. The *J. H. Cerilles State College*, through the *GAA 2022 (Fund 101)* intends to apply the sum of **SEVEN HUNDRED THOUSAND PESOS ONLY (PHP 700,000.00)** being the ABC to payments under the contract for **Procurement of Janitorial/Utility Services**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The *J. H. Cerilles State College* now invites **PhilGEPS registered** and **eligible bidders** bids for the SUPPLY OF UTILITY SERVICES, J. H. CERILLES STATE COLLEGE – MAIN CAMPUS, MATI, SAN MIGUEL, ZAMBOANGA DEL SUR. Bidders should have completed, within THREE (3) years from the date of the deadline of submission of bids, a **SINGLE LARGEST COMPLETED CONTRACT** similar to the project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Interested bidders must submit a certificate of registration or Licensed to Operate signed by government authorized agency/institution.
4. Interested bidders must submit a certificate of no delinquency or clearances from SSS, DOLE, PhilHealth, and Pag-ibig filed and at least issued in October 2021.
5. Interested bidders must submit complete file of bio-data of the utility personnel to be deployed, their drug test from a duly licensed drug testing center in the region conducted within the 3rd or 4th quarter of 2021 (July – December 2021).
6. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “*pass/fail*” criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
 - a. *Under Section 23.4.1.2 of the 2016 revised IRR of RA No. 9184 do not exist:]*
Paragraph A. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.
7. Prospective Bidders may obtain further information from **BAC Secretariat, J. H. Cerilles State College** and inspect the Bidding Documents at the **BAC Office, J. H. Cerilles State College- Pagadian Annex, Balangasan, Pagadian City, 8:00AM-5:00PM**.
8. A complete set of Bidding Documents may be acquired by interested Bidders on **December 5-27, 2021** from **BAC Secretariat** and upon payment of **PHP1,000.00**, for the Bidding Documents. The Procuring Entity shall allow the bidder to present its proof of payment for the fees *by facsimile*.
9. The *J. H. Cerilles State College* will hold a Pre-Bid Conference on **December 13 @ 10:00 AM** at **BAC Office, at J. H. Cerilles State College, Pagadian Annex, Balangasan, Pagadian City** or through video conferencing or webcasting *via* “Zoom”, which shall be open to prospective bidders.
10. Bids must be duly received by the BAC Secretariat through manual submission at **BAC Office, at J. H. Cerilles State College, Pagadian Annex, Balangasan, Pagadian City** on or before **December 27, @ 9:00 AM**. Late bids shall not be accepted.
11. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB Clause 14**.

12. Bid opening shall be on **December 27, @ 10:00AM**, at **BAC Office, J. H. Cerilles State College, Pagadian Annex, Balangasan, Pagadian City**. and/or via “Zoom”. Bids will be opened in the presence of the bidders’ representatives who choose to attend the activity.
13. The **J. H. Cerilles State College** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
