

**WHEREAS**, the Entity invited Bids for certain goods and ancillary services, viz., **PROCUREMENT OF SECURITY SERVICES (GAA) with Reference No. 8265670** and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **ONE MILLION FIVE HUNDRED NINETY-FIVE THOUSAND NINE HUNDRED TWENTY-FOUR PESOS AND 32/100 ONLY (PHP1,595,924.32)**, covering eight (8) months period from **May 1, 2022 to December 31, 2022**, hereinafter called the "**Contract Price**" for items herein attached as Annex A;

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents shall be deemed to form and be read and construed as part of this Agreement, viz.:
  - (a) the Technical Specifications;
  - (b) the Performance Security; and
  - (c) the Entity's signed Notice of Award.

In addition, **Double Dragon Security Forces Agency, Inc.** shall provide and make available to the **J.H. Cerilles State College** the required number of qualified, trained, licensed, and uniformed security guards and security.

**Double Dragon Security Forces Agency, Inc.** shall provide portable hand-held metal detector for each campuses assigned, respectively.

**Double Dragon Security Forces Agency, Inc.** shall make available at all times relievers and/or replacements to ensure continuous and uninterrupted service in case of absences. Relievers and replacements shall be qualified and carefully selected.

**Double Dragon Security Forces Agency, Inc.** shall require its security guards to wear the prescribed uniform while on duty.

**Double Dragon Security Forces Agency, Inc.** shall pay each of the security guards and security officers the monthly salaries and other fringe benefits in accordance with the Labor Code of the Philippines, pertinent laws, decrees, and other existing issuances governing private employment.

Cerilles State College with proof of receipt that it has paid its personnel assigned accordance with labor laws. **Double Dragon Security Forces Agency, Inc.** shall submit duly notarized monthly report of payment/remittance of SSS, Philhealth, Pag-ibig, and other lawful benefits.

**Double Dragon Security Forces Agency, Inc.** shall require each security personnel to follow the implementation of the covid 19 health protocols provided by IATF.

3. In consideration of the payments to be made by the Entity to the Supplier as hereinafter mentioned, the Supplier hereby covenants with the Entity to provide the goods and services and to remedy defects therein in conformity in all respects with the provisions of the Contract
4. The Entity hereby covenants to pay the Supplier in consideration of the provision of the goods and services and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the contract.




