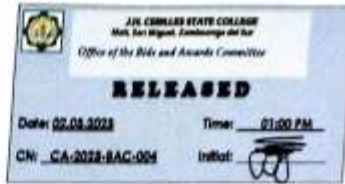

**CONTRACT AGREEMENT**

THIS AGREEMENT, made this 3<sup>rd</sup> day of February 2023 between J.H. Cerilles State College, Mati, San Miguel, Zamboanga del Sur (hereinafter called the "Entity") and ASPEN Multi System Corporation, El Moteverde, Subd., Barangay San Juan, Taytay Rizal (hereinafter called the "Contractor").

**WHEREAS**, the Entity is desirous that the Contractor execute (PB22-22) ACQUISITION OF EQUIPMENT FOR NURSING SKILL LABORATORY WITH REFERENCE NO. 9034195 (hereinafter called "the Works") and the Entity has accepted the Bid for **TWO MILLION TWO HUNDRED NINETY-TWO THOUSAND EIGHT HUNDRED PESOS ONLY (PhP 2,292,800.00)** by the Contractor for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as part of this Agreement, viz.:
  - (a) the Technical Specifications;
  - (b) the Performance Security; and
  - (c) the Entity's signed Notice of Award.
3. In consideration of the payments to be made by the Entity to the Supplier as hereinafter mentioned, the Supplier hereby covenants with the Entity to provide the goods and services and to remedy defects therein in conformity in all respects with the provisions of the Contract.
4. The Entity hereby covenants to pay the Supplier in consideration of the provision of the goods and services and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the contract.
