PROCUREMENT OF FUEL (DIESEL & GASOLINE) FOR CY-2026 EPA

1. The J. H. Cerilles State College, through the STF 2026 (Fund 164) intends to apply the sum of ONE MILLION NINE HUNDRED NINETY-NINE THOUSANDPESOS ONLY. (PHP 1,999,000.00) being the ABC to payments under the contract for PROCUREMENT OF FUEL (DIESEL & GASOLINE) FOR CY-2026 EPA). Bids received in excess of the ABC shall be automatically rejected at bid opening.

2. The J. H. Cerilles State College now invites PhilGEPS registered and eligible bidders bids for the above Procurement Project. Delivery of the Goods is 365 calendar days. Bidders should have completed, within FIVE (5) years from the date of the deadline of submission of bids, a SINGLE LARGEST COMPLETED CONTRACT similar to the project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).

3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184. a. Under Section 23.4.1.2 of the 2016 revised IRR of RA No. 9184 do not exist:] Paragraph A. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.

4. Prospective Bidders may obtain further information from JHCSC and inspect the Bidding Documents at the address given below from Wednesday, 31 December 2025 to Tuesday, 20 January 2026, 8:00AM-5:00PM.

8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 14.
9. Bid opening shall be on Tuesday, 20 January 2026, 10:00 AM, at BAC Office, J. H. Cerilles State College, Main campus, Mati San Miguel Zamboanga del Sur.
