Description

1. J. H. Cerilles State College, through the STF 2026 (Fund 164) intends to apply the sum of TWO MILLION NINE HUNDRED FIVE THOUSAND THREE HUNDRED NINE PESOS AND 12/100 CENTAVOS. (Php 2,905,309.12) being the Approved Budget for the Contract (ABC) to payments under the contract for COMPLETION OF MULTI-PURPOSE BUILDING AT JHCSC PAGADIAN CAMPUS. Bids received in excess of the ABC shall be automatically rejected.

2. J. H. Cerilles State College now invites bids for the above Procurement Project. Completion of the Works is required within 60 calendar days. Bidders should have completed within five (5) years from the date of the deadline of submission of bids, a SINGLE LARGEST COMPLETED CONTRACT similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).

Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184. Interested bidders may obtain further information from JHCSC and inspect the Bidding Documents at the address given below from Wednesday, 6 May 2026 to Monday, 25 May 2026, 8:00 AM – 5:00 PM

4. A complete set of Bidding Documents may be acquired by interested Bidders Wednesday, 6 May 2026 to Monday, 25 May 2026 from BAC Secretariat and upon payment of PHP5,000.00, for the Bidding Documents.

It may also be downloaded for free of charge from the Philippine Government Electronic Procurement System (PhilGEPS) and the JHCSC website, provided that payment of the non-refundable fee as above for the Bid Documents shall be made prior to submission of bids. 7. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 16.

8. Bid opening shall be on Monday, 25 May 2026, 10:00 AM at BAC Office, J. H. Cerilles State College, Main Campus, Mati San Miguel, Zamboanga del Sur.

9. Bidders shall provide an active and valid email address to ensure timely and efficient communication. All notifications will be sent via email and considered received
